PARK AND RV PARK REGULATIONS AND FEES

ORDINANCE 091808 (04)

AN ORDINANCE AMENDING THE CITY OF QUITMAN, TEXAS – CODE OF ORDINANCES REVISING THE REGULATIONS AND FEES FOR THE GOVERNOR HOGG PARK AND RV PARK

WHEREAS, the periodic review and revision of regulations and fees is necessary to maintain efficient and effective management of park operations, and

WHEREAS, certain revisions to such regulations and fees have been found to be appropriate.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF QUITMAN, TEXAS, THAT:

SECTION I

Sections 93.01, 93.02, and 93.07 through 93.09 of the City of Quitman, Texas – Code of Ordinances shall replaced or added as follows:

"Sec. 93.01. Guidelines for Governor Hogg Park and RV Park.

- (A) The City Secretary-Administrator shall prescribe such rules for the Governor Hogg Park and RV Park as may be necessary to maintain order and safety, protect City and private property, and maintain and aesthetic and cleanliness standard.
- (B) Provided such rules are prominently posted or have been provided to users of specific services, violation of such rules shall be a violation of this Code.
- (C) Exceptions to such rules as well as sections 93.02, 93.04, 93.05, 93.07, 93.08, 93.15, and 93.17 of this Code may be permitted with prior written approval of the City Secretary-Administrator.

Sec. 93.02. Park Hours.

- (A) Regular park hours shall be from sunrise until 10:00 PM.
- (B) Use of the park, including the parking lot, but excluding the RV park, shall be restricted to park hours and it shall be a violation of this Code use any area of the park during a time other than during park hours, except as may have been specifically permitted in writing by the City Secretary-Administrator.

Sec. 93.07. Animals in the Park.

- (A) All animals in the park shall be under the direct and immediate control of a person either by leash or other restraint.
- (B) Pet owners shall be responsible to remove all animal waste from the park.
- (C) Horses shall be allowed only on paved surfaces and the field west of the RV Park.

Sec. 93.08. Park Facility Use.

(A) The City Secretary-Administrator may prescribe rules for the use of park facilities and may grant permit for exclusive or non-exclusive use of park facilities to any person or group as may be deemed appropriate for such facilities. (B) Permit fees for exclusive use of park facilities shall be as follows:

Section of the Park (1/4)	\$100.00	\$150.00	\$200.00	\$200.00

- (C) Permit fees for any commercial use shall be double.
- (D) Permit fees for use by a governmental agency or a local civic / service organization may be reduced or waived at the discretion of the City Secretary-Administrator.
- (E) Permit fees for a use solely intended to raise funds as a benefit or for aid may be reduced or waived at the discretion of the City Secretary-Administrator.
- (F) Security deposits shall be deposited upon receipt and shall be refunded by check payment to renter only after the cost of any clean-up, reset of movable items, or repair caused by the use shall have been deducted. No security deposit shall be reduced or waived.
- (G) Permits for use of a facility under this section are not inclusive of any other permit which may be required under any other part of this Code.
- (H) An individual interfering with the exclusive use as permitted shall be in violation of this Code.

Sec. 93.09. RV Park Regulations and Fees.

- (A) It shall be a violation of this Code to occupy or otherwise block access to any RV spot without a current permit for use which is properly displayed.
- (B) No permit shall be issued without proper application, including:
 - (1) renter name,
 - (2) renter physical home address (with exception only by City Secretary-Administrator),
 - (3) renter mailing address,
 - (4) renter contact phone number,
 - (5) renter vehicle information, including RV and other vehicles description and license,
 - (6) and names of all members in party.
- (C) RV Rental fees are hereby set as follows:
 - (1) Daily, \$20
 - (2) Weekly, \$120
 - (3) Monthly, \$360 (amended by O092508(02))
- (D) No vehicle or trailer shall be parked in the RV park which does not have a current registration and / or state inspection."

SECTION II

The City Secretary-Administrator is hereby authorized and directed to publish the caption of this Ordinance and the general penalty clause of the Code of Ordinances AND this addition shall become effective 30 days after such publication.
